#### CONVENTION UPDATE

Registration is now over 1050 and more are coming in daily. The registration for this convention should come close to 1100 total after final tallies are made and late registrants are finally able to clear their calendars. We recognize that jobs, other than calling, can create scheduling problems and we will do all we can to facilitate your attending. It is possible that we may not be able to get a badge for the very late registrants but we will give it our best shot. This year the convention badge will reflect the Southwestern nature of our convention and will show that your fees have been paid. Since the hotel has several concessions on the ground floor, they require that our exhibitors only sell to bonafide registered CALLERLAB attendees. wear your badge at all times.

We would like to remind all of you again that the entire office staff will be leaving for Phoenix on Wednesday March 27, 1985. If you must cancel and you do not cancel prior to March 26, 1985, please call us at the Hyatt Regency in Phoenix so that you can avoid the late cancellation charges. It would be best if you also confirmed this in writing to the office of the date you called and the person to whom you gave the message in the event you are unable to talk to John Kaltenthaler, Herb Egender Bunny Broderick or Carol Neff. Please note that late cancels, except in dire emergencies, may forfeit their convention deposit to cover the costs of meals that were ordered in your name.

#### Weather in Phoenix

During late March and early April, the average temperature in Phoenix is high 76's to low 80's with the nights possibly getting into the high 50's. Thus for our convention, we can anticipate mild weather with an 85% chance of continuous sun. We might suggest a sweater and windbreaker for the evening at RAWHIDE even though the temperature probably won't dip into the 50's until well after midnight.

#### Mainstream Quarterly Selection

For the quarter beginning April 1, 1985, Harold Bausch, Chairman of the CALLERLAS Mainstream Quarterly Selection Committee, has announced that there will be no new quarterly figure. None of those calls being considered for quarterly selections this quarter received enough ballots to be selected.

The current quarterly selections are Chain Down The Line and Grand Parade.

#### Note Regarding Straw Ballot Included in the February 1985 Issue of Direction

There seems to be some confusion resulting from the ballot included in the last issue of DIRECTION (Feb 85) at the request of Jack Lasry, Chairman of the Program Coordinating Committee asking the question "Who is your partner in a wave?" This was a straw poll in an attempt to get the entire membership's feelings regarding this question.

There may also be some confusion regarding the "crossing rule" clarification and the definition in each program. Once a call has been defined, that definition would apply whenever that call is used regardless of the dance program in which it is called. Thus, true standardization would apply. If a call is not included until the Plus or Advanced Dance Programs, it would first be defined for that program and apply whenever it is called thereafter.

#### Mainstream Definitions Committee

Ken Kernen, Chairman of the Mainstream Definitions Committee, has advised that several valid petitions have been received proposing changes in the following Mainstream definitions. These are being included in this issue of DIRECTION for your review and consideration prior to the 1985 Phoenix Convention where they will be voted upon.

As a result of actions taken at the convention in Chicago in April 1984 and from petitions received by the CALLERLAB Home Office, several items need to be brought to your attention.

(1) In accordance with the approved procedures for changing an existing CALLER-LAB definition, a petition of more than 25 CALLERLAB members has been received to "consider changing the definition of U Turn Back so that, in all cases in which dancers have partners, they will turn back by turning in toward the partner". This, in effect, would change U Turn Back as follows:

From: 13(a) Starting Formation: Single Dancer

Definition: The dancer does an in place about-face turn (180°), turning toward partner unless the body flow dictates otherwise. If alone (i.e., no partner), the dancer turns toward the center of the set. If the dancer is facing directly toward or away from the center of the set, he may turn in either direction.

To: 13(a) The dancer does an in place about-face turn (180°), turning toward partner. If alone (i.e., no partner), the dancer turns toward the center of the set. If the dancer is facing directly toward or away from the center of the set, he may turn in either direction.

This would eliminate the phrase "unless the body flow dictates otherwise".

NOTE: One of the possible changes that would be brought about by this change would be in the case of Right and Left Thru and U Turn Back. As the definition

now stands, body flow dictates that the lady turns left face and the gent turns left face when turning back. The proposed change would require that the lady still turn left face, but the gent would turn right face, toward partner.

(2) As a reminder for you, the Turn Back Family of 13(a) U Turn Back and, (b) Backtrack (including couple or single dancer) was changed at the April 1984 Convention to eliminate the Couple Backtrack. As such, the definition of 13(b) is changed as follows:

From: 13(b) Starting Formation: Couple or single dancer

Definition: From a couple formation, both dancers do a U Turn Back, turning toward each other. If hands are joined as in a promenade, Backtrack is completed without releasing hands. If a single dancer is directed to Backtrack, he does a U Turn Back by stepping out and turning away from partner or the center of the set.

To: 13(b) Starting Formation: Single dancer

Definition: The dancer does a U Turn Back by stepping out and turning away from partner or the center of the set.

Additional discussion is planned for this at our committee meeting in Phoenix. Plan on being there and voicing your opinion!

(3) The second petition concerns the definition of 7(a) Right and Left Grand. The petition for reconsideration of the definition of Right and Left Grand, initiated by Ed Foote, reads as follows:

"The definition says 'partners face' and there are some occasions when Right and Left Grand can be called without facing your partner."

Ed's suggested change on the petition is to add after "partners face" in parentheses (if not already facing).

A letter has since been received from Ed indicating that the definition in its original form and also with the addition of the petition's suggested phrase is technically incorrect because it implies that the action must be done with one's original partner.

I would like to suggest that the issue we need to address is to eliminate the word "partner" and "face" from the definition.

Since the starting formation requires dancers to be facing or adjacent to the opposite sex, it's not necessary to ask them to face in the definition. In order to eliminate the "partner" problem, it is suggested to change the definition as follows:

From: 7(a) Starting Formation: Square or circle or any position where dancers are facing opposite sex, men facing counterclockwise, ladies clockwise.

Definition: Partners face, join right hands and pull by. Each moves ahead, around the circle (men counterclockwise, ladies clockwise) and each gives a left hand to the next, a right to the next and a left to the next until each dancer meets his partner.

To: 7(a) Starting Formation: Square or circle or any position where dancers are facing, or adjacent to, the opposite sex, men facing counter-clockwise, ladies clockwise.

Definition: Dancers join right hands and pull by. Each moves ahead, around the circle (men counterclockwise, ladies clockwise) and each gives a left hand to the next, a right to the next and a left to the next until each dancer meets the person with whom he started.

(4) Courtesy Turn (15) was considered at the April 1984 Convention on a one (1) year trial basis to be limited to turning the girl on the man's right for the Basic and Mainstream Programs. On a permanent basis, the definition would change as follows:

From: 15 Starting Formation: Couple, facing dancers

Definition: The man (left hand dancer) takes the lady's (right hand dancer) left hand (palm down) in his left (palm up) and places his right hand in the small of the lady's back. Working as a unit, the couple turns around with the left hand dancer backing up and the right hand dancer walking forward. Unless otherwise specified, the couple faces the center of the set or the center of the formation in which it is working.

To: 15 Definition: The man takes the lady's left hand (palm down) in his left (palm up) and places his right hand in the small of the lady's back. Working as a unit, the couple turns around with the man backing up and the lady walking forward. Unless otherwise specified, the couple faces the center of the set or the center of the formation in which it is working.

Please give the above proposed Mainstream definition changes serious consideration and be prepared to vote upon them at our upcoming Phoenix Convention!
