

Board of Governors Election

This year we will be electing six (6) new members to the Board of Governors. We will be voting on the slots for the vacancies of Al Brundage, who resigned, along with those incumbents whose terms expire in April of 1986: Harold Bausch, Orphie Easson, Frank Lane, Jack Lasry and Bill Peters. Since the By-Laws allow for unexpired terms to be filled according to the popular vote, you will be voting for six (6) candidates; the five highest vote getters will be assigned five year terms and the sixth highest vote getter will be assigned the unexpired term of Al Brundage.

Please note, however, that we are currently revising our By-Laws to comply with the revisions to the California Corporate Code for Non-Profit Organizations. Among other items requiring a change are the terms of office for elected members of the Board. In 1984, California revised the codes to reflect terms of office not to exceed three years. Therefore, while we are theoretically electing candidates for the Board to five year terms, please understand that none of them will serve more than three years under this election. Details of the changes to the By-Laws are under study and you will have an opportunity to review the By-Laws prior to their passage and implementation. The logistics of the assignment of terms is a function of your elected Board Members and will be handled in Baltimore.

Beginning on the following page are brief write-ups submitted by each candidate. The ballot is a separate attachment to this issue of DIRECTION since only members in good standing are permitted to cast a ballot. Associate Members, Subscribers and Apprentices do not have a ballot in their mailing.

For your vote to be counted, it is mandatory that you be a member in good standing. Some of you must return a check for your dues along with your ballot in order to have your vote count. This is a very small percentage of our members but we wanted to remind all of you of the rules passed by our membership. Each member in good standing may vote for not more than six (6) candidates. You may vote for less than six if you so desire. It is not permissible to vote for any candidate more than once (non-cumulative voting). All ballots must reach the office no later than November 15, 1985 to be counted. Any ballot whose outer envelope has a postmark after that date or does not have the name of the member will not be counted and you will have forfeited your vote. As previously stated, if you do not vote, you give up your right to complain. We urge each of you to take the time now and cast your ballot accordingly!

Results of the election will be announced in the December issue of DIRECTION. A special press release will also be mailed to publications and caller associations announcing the results of this important election. Remember, YOU ARE CALLERLAB! Buddy Allison began calling in 1973 and has been active since that time. Buddy calls for two home clubs and two caller-run workshop groups. He also travels throughout the country on calling engagements. He has called Western, or club dancing, exclusively for the past 25 years. His clubs range from Mainstream through Challenge. Red has served in many capacities in New England square dance groups; he has been president of Springfield Area Callers' Association as well as a delegate and chairman of the New England Council of Callers' Associations, an organization which he was instrumental in founding. He is now a member of the Connecticut Square Dance Association and an accredited member of He has made several recordings for Hi-Hat and CALLERLAB. Jay-Bar-Kay records and is currently recording for Red Boot Star. He calls at weekends, festivals, and conventions throughout the Eastern United States, as well as being club caller for several groups in the New England and New York State areas. Red and his wife, Shirley, make their home in South Hadley, Massachusetts. They have four grown children. Red is a full time square dance caller.



Mike Degmetich has been calling for over ten years, square dancing for almost 30 years and teaching and cueing rounds for 12 years. Mike holds down a full time teaching position while conducting square and round dance programs in the metropolitan area of the Santa Clara Valley in California. Mike has been an active member of CALLERLAB over the past six years, participating in several interest sessions and currently serves as Chairman of the Education Committee. "Square dancing has been the major recreational activity of my adult life. I want to work toward maintaining the essence of this pleasant, enjoyable folk activity while allowing room for reasonable growth and change."



Betsy Gotta has grown up in square dancing. When she started dancing over 32 years ago, she learned squares, rounds and contras. As a caller (since 1962), Betsy has kept this diversity of interests by calling for Basic, Mainstream, Plus, Advanced and Contra programs. Currently she is starting a C-1 program. As a member of CALLERLAB since 1976. Betsy has served on the following committees: Mainstream QS, Plus, Plus QS, Caller Association Liaison, Contra and Caller Education. She has made presentations at conventions and served as a salesperson for the CALLERLAB booth. Her husband, Roy, who cues rounds, participates in the Callers' Partners Program. At home, Betsyis a founding member of the local callers' association (CCNJ), serves actively in several callers' and dancers' associations, has run several callers schools and works continuously with newer callers on a one-to-one basis. Because of her many years of experience and her

understanding of the overall square dance picture, Betsy feels that she has much to offer the Board of Governors and her fellow members of CALLERLAB.



Bob "Fatback" Green graduated from square dance class in 1978 and began his calling career in 1979. Presently, he calls for two local clubs in the Birmingham area and has taught beginner classes almost every year since he began calling. He has been the featured caller at several major festivals and travels frequently on weekends to call special dances throughout the Southeast. He is a recording artist on the LOU MAC record label. Bob has been a member of the South Carolina Callers Association, is now a member of the Alabama Square Dance Callers Association, and is currently serving as president of the Birmingham Area Square and Round Dance Callers Association. joined CALLERLAB in 1983 and has attended each of the conventions since that time. Bob feels that, as the leaders of our activity, we have the opportunity and responsibility to affect positive change that will insure the health and long-life of Square Dancing. Bob would consider it an honor to serve on your Board of Governors.



Eddie Mayall tallies 25 years of calling experience and has been a CALLERLAB member since 1974. He has served as a member on several CALLERLAB panels and is currently on the quarterly selections and Mainstream Committees as well as the Ad Hoc Committee. He teaches classes and is club caller for two clubs, one of which he has been club caller/class teacher for the last twenty years. As a dancer, he served as club officer in numerous positions and has also held a number of offices in his local callers' association. Eddie believes that this experience has given him strong insight into the concerns of callers and dancers alike and he would like the opportunity to aid in the strengthening of our activity. Eddie has been employed by Digital Equipment Corporation for twenty-five years and enjoys his position as a senior engineering supervisor.



Darryl McMillan has been calling squares since 1969 and is an accredited member of CALLERLAB. Darryl travels most weekends doing festivals. He has called in most of the U.S. as well as Canada and Japan. He has been on the staff of some of the leading square dance resorts. On a regular basis, Darryl teaches beginner squares, beginner rounds and calls for one Plus and one Advanced group in Panama City, Florida. Darryl is owner/producer of "Ranch House Records" and a graduate of Auburn University with a degree in Civil Engineering. He resides in Lynn Haven, Florida with his wife, Ann and their two sons, Darren and John Derek.



Jack Murtha has been calling for thirty-one years. Invited to join CALLERLAB at its first meeting in St. Louis, Jack has attended every CALLERLAB Convention to date. He has chaired the Definitions and Mainstream Committees and served on the Mainstream Quarterly Selection and the Accreditation Committees and is currently on the Ad Hoc Committee studying some of square dancing's problems. Jack has a special interest in teaching. He has been a professional teacher for thirty-five years and a professional consultant to teachers for twenty-five years. He has brought this expertise to square dancing, writing articles and running seminars on the subject for callers, teaching them to control the difficulty of their calling for increased dancer success and enjoyment. Contra of the Quarter

Those of you who are well into contras as separate programs or as a part of your on-going square dance planning, have discovered what a valuable phase of the activity these line dances can become. Undoubtedly you have developed certain sources for obtaining material and you may also be creating contras on your own. However, to those of you who haven't tried contras and would like a simple starter, here's a suggestion — try a contra in a circle.

For this quarter, we're going to feature one that most contra cuers have used - CONTRAROTATION. This dance works best if you have no fewer than 20 couples. To get ready to start, have the couples promenade counterclockwise around the hall. Then have two couples promenade together in lines of four (also moving counterclockwise). Bend the Line so one of the couples has its back to the center, while the couple they face has its back to the wall. Have the two ladies chain so that now

each man has his partner directly across from him. The dance is now ready to start.

Remember, the calls are the same as in a square. As the dancers stand facing their partners — across the circle — that man's corner is on his left (in the big circle), the lady's corner is on her right. Here's the dance:

CONTRAROTATION

Formation: A large circle of couples facing couples, one couple with backs to COH, other couple facing COH. Dancers now in outer circle will remain in that circle and dancers now in inner circle will remain in that circle during the promenades and to start dance again each time.

Music: Any well-phrased 64 count Reel.

Intro ---, With the corner do sa do
1-8 ---, Same girl bow and swing

9-16 ---, Put her on right and circle four

(Circle is composed of the couples who swung and those they face in other circle. Circle to left once around.)

17-24 - - - - , Star left back to place

(Star left exactly once around to finish with the dancers in the outer circle facing counterclockwise LOD and dancers in the inner circle facing clockwise RLOD.)

25-32 - - - - , The way you face promenade in twos

(Remaining in original circles, dancers promenade in twos in the direction they are facing, outer circle in LOD and inner circle in RLOD.)

33-40 - - - - , Wheel as a couple come back

(Each couple does a wheel turn to face the opposite direction, then promenades back to face original partners.)

41-48 - - - - , Those two ladies chain

49 - 56 - - - , With the music chain them back

(All dancers are still in original circles, facing original partners. The dance starts over at this point.)

If you're already a part of the Contra Committee, you'll be receiving a committee letter soon. If you're not on the committee and would like to learn more about this phase of the activity, please send a postcard to John Kaltenthaler, our Executive Secretary and ask him to add your name to the Contra Committee roster.

Dance Program Lists

When we first published the Plus Program sheets, we neglected to revise the call LINEAR CYCLE as being from waves only. We now have the revised sheets in stock for bulk purchase at \$2.50 per hundred including postage. (Please see revised "sale item" sheet included with this mailing.)

Quarterly Selections

The schedule of quarterly selections is on a staggered basis with the Mainstream QS figures being published for the periods beginning January 1, April 1 and October 1. We have no MS QS for the summer months. The PQS moves are for the periods beginning February 1, May 1, August 1 and November 1. For the AQS, the effective periods begin on March 1, June 1, September 1 and December 1. No dance program is required to have a QS move for each period but the votes of the committee for that particular program are in accordance with a predetermined schedule. As a service to our callers, we will periodically state the current selections. As of September 1, the following QS are current:

1986 Baltimore Convention Update

The 1986 convention invitations have been sent out and the returns are coming in daily. We are all looking forward to our 12th annual CALLERLAB Convention with great anticipation. There are many important issues to be discussed and voted upon. We urge you to attend the upcoming convention scheduled to be held March 24-26, 1986 in Baltimore! Remember - to save you time and trouble, send the hotel reservations to us and we will annotate your records and send them to the hotel for processing.

Some of the subjects to be discussed this year include the normal committee functions as well as the special Ad Hoc Committee findings and recommendations. Additionally, we will have interest sessions on RECRUITMENT, RETENTION, FUN IN DANCING/CALLING, A 25 WEEK LEARN TO DANCE PROGRAM, TEACHING FOR DANCER PLEASURE, and ENTERTAINING THE DANCER.

For the first time, we will also hold an Indoctrination Session for the newly established Apprentice program as well as any other interested callers who might wish to avail themselves of this learning experience. This session will deal with the standards we have established to include Timing, Styling, Definitions of the Mainstream and Plus Programs, Caller Training Curriculum and some dancing experience. The intent is to learn by doing and to explain how we got where we are. The Sunday evening social hour and subsequent Orientation session will again be repeated as well as the usual functions of meals, awards and entertainment.

Your Convention Planning Committee (Executive Committee) feels this is a fine program with many of our outstanding leaders in attendance as panelists. We will have exhibitors and space for free static literature displays. So far, we have more than 150 registered to attend with 56 couples and 25 single callers as well as staff. Baltimore is very pleasant at that time of year and the revitalized Inner Harbor is a

fun place to visit with its shops and attractions. For you history buffs, Ft McHenry, the birthplace of our Star Spangled Banner, Annapolis, and Washington, DC are all close. Side trips to Gettysburg and other Civil War memorials can easily be arranged. If you just have to see Atlantic City, it is located about three hours away by car or motor coach.

TV on Public Broadcast Stations or Educational TV

Just one last shot to remind you that beginning at 4:00 PM on October 5, the SC Educational TV station will uplink the TV series of Square Dance Instruction for 26 consecutive weeks. This broadcast is at no charge to the receiving station and it is up to each of you and your local dancers and publications to urge the PBS stations in your area to broadcast this series of programs. If you have a VCR unit, you might also wish to tape them and make them available as lesson supplements. Where this has been done, the retention rates have been far higher than where no supplements were used. CALLERLAB is proud to be a part of this promotion. The ball is in your court! Pick it up and do something for the activity! Help promote square dancing and classes in your areas!

FINANCIAL REPORTS

On the next few pages, you will find the financial reports of our last fiscal year. A quick look will show that we operated in the black. With the advent of the newly created Apprentice Program, we should increase our dues by a considerable sum and thus operate in the black with the existing dues structure. This will take place, however, if all members do their parts in encouraging qualified callers to become either Subscribers or Apprentices this year. Please note that the dues for Subscribers and Apprentices are the same as for full members except that if they affiliate after the convention the dues are prorated according to the quarter in which they become affiliated. If a caller affiliates in October, the dues would only be \$25.00 and that would cover the Subscriber or Apprentice through the convention in Baltimore. Subscribers and Apprentices get the full insurance coverage. They get the publications and are entitled to attend the conventions. They may obtain selected PR items and may order a badge to show their affiliation with CALLERLAB. The badge for the Subscriber is the same as for full members. The Apprentice badge, however, is a different color background but a similar design.

Pot Pourri

We are saddened along with many thousands of readers to see the termination of a fine quality magazine which has served square dancing well over many years. The enclosed Press Release from SQUARE DANCING (SIOASDS) tells the story. Bob Osgood has done a great deal for square dancing over the years and many of us owe him a deep debt of gratitude. He has contributed freely of himself and his resources to promote square dancing whenever the opportunity arose. He, along with several others from the Hall of Fame, formed CALLERLAB. He acted as the initial Executive Secretary and donated many hours of free service from his staff. When it came time to donate funds to put CALLERLAB into the black financially, Bob was there. It will take several years to fully let go but we are glad that he will be able to operate with a little less pressure and time constraints.

On behalf of CALLERLAB, then, we wish him, his family and staff well in their future endeavors. We sincerely thank you, Bob, for a job well done.



SPIN THE NET - Author - Don Beck

Starting Formation(s): Parallel Ocean Waves or Eight Chain Thru
From parallel Ocean Waves, all Spin The Top, to form a momentary tidal wave.
Without stopping, the very center four dancers, in their own wave do another Spin
The Top, while the other four dancers Cast Off 3/4 and the outfacers will Run.
Ending Formation: 1/4 Tag - Timing: 16

Singing Call Figure: Heads (sides) Square Thru, Dosado to a Wave, Swing Thru, SPIN THE NET, Centers Recycle, Pass Thru, Swing The Corner & Promenade.

Comments: Those that have used this call find good dancer reaction along with a reasonably quick teach. Don informs us that if started from normal waves (right hand waves with men on the ends, ladies in the center), you Swing Thru and then SPIN THE NET, the Spin The Top actions will be from the most common positions and will end in a 1/4 Tag with a normal wave in the center and normal couples on the outside.

AN ANNOUNCEMENT FROM THE EDITOR of SQUARE DANCING (Sets in Order) Magazine

The December, 1985, issue of SQUARE DANCING will bring to a close 37 years of continuous publication. As you can imagine, reaching this major decision has taken a great deal of thought and contemplation. In weighing this change, we have determined that rather than transfer the ownership/editorship to someone else, we would simply ring down the curtain on a magazine that has chronicled a vast era of square dancing history.

After having personally nursed 444 issues from concept through mailing, both Becky and I feel we will have said what we've had to say, helped where we could and supported, to the best of our ability, this activity which we have enjoyed for 47 years and in which we expect to be active for a long time yet to come.

This change won't mean a complete retirement for us. It will take at least a couple of years to get our archives in order and to wrap up projects that have been on the back burner. We'll continue to handle the sales of our products and to operate The American Square Dance Society which maintains the Hall of Fame, the Silver Spur Awards and the Scholarship program. We will remain active with Callerlab and continue the various leadership conferences we handle each year.

The American Square Dance Society, which served as the home office for Callerlab in its early stages, produces and sells The CallerText, The Caller/Teacher Manual, the Basic/Mainstream, Plus and Indoctrination Handbooks among other specialized square dance items. We plan to continue our Winter and Summer Asilomar Vacation Institutes which we've produced since 1951, as well as a few square dance tours, something we've been doing since 1961. We can be reached at the same address with the same telephone number as in the past.

And so it is that we bow out of one era of our lives and into another phase which will allow us greater time with family and friends and an opportunity to do those things we've wanted to do for so long. Thank you for your continued interest in square dancing and your support of SQUARE DANCING Magazine. We hope to keep in touch. -- Bob Osgood

Note 1 - Summary of Significant Accounting Policies

Organization

The association, a non-profit organization, promotes the art of square dance calling among all nations of the world.

For both tax purposes and financial reporting, the association uses the cash basis of accounting, revenues are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

Taxes

The association qualifies as a tax exempt organization under section 501(c)(6) of the Internal Revenue Code and therefore, is not subject to federal and state income taxes.


Fixed Assets


Fixed assets are stated at cost. Depreciation is calculated on straight-line and ACRS methods over the assets' useful lives of 5 - 7 years. For the current fiscal year, depreciation in excess of straight-line is \$275.20 with a cumulative excess of \$3,238.05.

Note 2 - Rent

The association rents its office facilities from John Kaltenthaler, the executive secretary, for the fee of \$275.00 per month, increasing to \$300.00 per month in April of 1985.
