Board of Governors Election

Each year in the September issue of DIRECTION, we list the nominees for the Board of Governors. With the changes in the By-Laws, the terms of office are now limited to three (3) years. This year we will be electing nine (9) new members to the Board of Governors. There are currently nine vacancies on the Board, eight (8) of which are full 3 years terms. The ninth spot to be filled will be a one (1) year term to fill the vacancy created by the resignation from the Board (effective at our 1988 Reno Convention) by Gene Trimmer. Gene has advised that he will be retiring from Square Dance Calling and will be unable to continue serving on the CALLERLAB Board of Governors.

Short biographic sketches are included in this issue of DIRECTION for your perusal to aid in making your voting decision. The ballot is a separate attachment to this issue of DIRECTION since only members in good standing are permitted to cast a ballot. Associates, Subscribers and Apprentices do not have a ballot in their mailing.

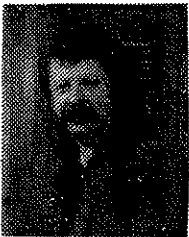
For your vote to be counted, it is mandatory that you be a member in good standing. Each member in good standing may vote for not more than nine (9) candidates. You may vote for less than nine if you so desire. It is not permissible to vote for any candidate more than once (non-cumulative voting). All ballots must reach the office no later than November 15, 1987 to be counted. Any ballot whose outer envelope has a postmark after that date, or which does not have the name of the member listed on the outer envelope will not be counted and you will have forfeited your vote.

We urge each of you to take the time now and cast your ballot! The results of this election will be announced in the December issue of DIRECTION. A special press release will be mailed to publications and caller associations announcing the results of this very important election. Remember, YOU ARE CALLERLAB! Please vote and return your ballot today. Place your name on the outer envelope. Please return your ballot prior to November 15, 1987.

Bill is the author of many calls, books and articles. These include the Top Ten, The Slight Caller's Textbook, and a five year series of articles in Square Dancing Magazine. He publishes a national note service for callers under the auspices of the SCVCA of which he is research chairman and past president. He has been a continuous contributor to CALLERLAB from the beginning. He is a Caller-Coach and conducts callers' schools and seminars. He is currently serving on the CALLERLAB Board of Governors and would be pleased to continue serving in the best interests of square dancing.

Decko Deck



Born 1919 in Jet, Oklahoma, the son of a rancher/farmer. Decko, formally addressed as H A Deck, Lt Col, USAF (Ret), is a graduate of the University of Oklahoma. A caller since 1950, Decko joined CALLERLAB in 1975, became a Caller-Coach in 1985 and has actively contributed to several committees, including Membership, Ethics, Accreditation, Caller-Coach and Caller Training. He is chairman of the MSQS Committee. Decko regularly calls for five square dance clubs and one contra club. He cues rounds for his clubs in the DC area, teaches at a senior citizen center and conducts a CDP under the auspices of a county recreation department. Decko is the founder and director of the National Caller's Institute where he conducts an annual callers' college. He also conducts seminars on special subjects for caller's associations. Decko, together with his taw of 46 years, Lou Deck, are better known as Lou & Decko. In years past, Decko travelled extensively as a travelling caller throughout the Eastern U.S. and Canada. Lou has been an active and equal partner with Decko throughout their 38 years of square dancing, encouraging, guiding and counseling callers' partners wherever and whenever possible.

Herb Egender



Started square dancing with Lloyd "Pappy" Shaw in 1937 and has been involved since then except for WW II years when he flew combat missions and was a POW in Germany. Taught and called/cued squares and rounds in many areas of world during 30 years in Air Force. Retired Colonel USAF. Early retirement Metropolitan State College. Professor Emeritus. Member of CALLERLAB since 1974. Has attended all conventions. Previously served partial term on Board and Executive Committee. Resigned to become first and, to date, only Assistant Executive Secretary. Accredited Caller-Coach. Conducts seminars, clinics and callers' schools. Elected to Denver Area Square & Round Dance Council Hall of Fame. Recipient of ASDS Silver Spur Award. Herb says, "During eight great years as Assistant Executive Secretary, my position rightfully precluded my voicing my opinion on a number of key issues. I would like that opportunity again in the hope of helping a wonderful activity which has been a part of my life for a long time, and an organization to which I am committed."

Bob Green



"I began my calling career in 1979 while I was still taking square dance lessons in Camden, South Carolina. After calling for several clubs in South Carolina and traveling the Southeast extensively, I moved to Birmingham, Alabama in 1983. Although I have not been calling as long as some of the other candidates on this year's slate, my many years of experience as an independent businessman are what I would bring to the Board. I feel that it is important to have a mix of experienced full time local or club callers, National or "big name" callers and those callers who call on a part-time basis. For years, I have been regarded an "idea man" and am proud to take credit for developing the idea of creating the Apprentice category of affiliation with CALLERLAB which opened our membership to those callers who don't qualify for full membership. I was also the impetus behind the newly created Foundation For The Preservation and Promotion of Square Dancing which will help our activity as a whole. This is my third campaign for a spot on the Board and I would like your vote!"

Mike Jacobs



Mike Jacobs has grown up in Square Dancing. Mike started dancing in 1962 at the age of 10 and began calling in 1971. Presently he resides in Fairfax, Virginia, having moved this past January from Louisville, Kentucky. Mike calls full time at weekends and festivals in thirty-three states and Canada and is currently building a square dance program in his new location. He is past president of the Kentucky Callers Association, a CALLERLAB member since 1976 and present Chairman of the CALLERLAB Advanced Quarterly Selection Committee. Mike feels that CALLERLAB must serve as an integrating mechanism among callers, integrating the established caller with the new, the entertainer with the teacher, the special interest group with those of a broken spectrum, and, most importantly, the caller with the dancer. Larry Letson has been calling since 1967 and records on ESP Records. He has been a member of CALLERLAB since 1976 and serves on the Plus Quarterly Selection Committee. He has called for various festivals in 22 states in the U.S. and in seven foreign countries. Larry spends his winter months as resident caller for two resort parks in the Rio Grande Valley of Southern Texas with his wife, Vicki and their infant son, Kyle. Larry's main reason for wishing to be elected to the Board of Governors is to act as a liaison between the various callers and dancers across the country and CALLERLAB. Many people have very valid points of concern that they express to him on the road but they never take the time to write a letter to CALLERLAB with their ideas. Melton Luttrell



Since 1949, Melton and Sue have been actively engaged in all phases of square dance calling and promotion. He attended Herb Greggerson's callers school 1950-52; owned and operated a record company; promoted square and round dance institutes for over 20 years; designed and managed Swingtime Center, one of the nation's finest square dance facilities; featured caller for festivals in over 35 states, Canada, England & New Zealand and a staff member at Fun Valley, Asilomar, and Kirkwood Lodge. Honors include American Square Dance Society Hall of Fame 1977 and CALLERLAB Milestone Award 1986. He's club caller for 6 clubs (3 in excess of 25 years); teaches classes continually (over 12,000 dancers to date); and teaches & cues for a round dance club. A CALLERLAB Board of Governors member since its beginning in 1973, Melton has attended every convention and every Board meeting held to date; served as Chairman of Halls for Square Dance and Styling Committees. Melton seeks to continue serving because he earnestly believes he expresses the viewpoint of the club caller and always places the interest of square dancing above his own personal achievements.

Eddie Mayall



Eddie Mayall has been enjoying his calling career since 1960, and has been a CALLERLAB member since 1974. He has served as chairman of the panel on Plus Choreography and has served as a member on several other CALLERLAB panels. He is currently on the quarterly selections and Mainstream committees. Eddie offers a variety of knowledge and understanding, both as a dancer and caller. As a dancer, he served as club officer in numerous positions and has also held a number of offices in his local callers' association. He currently is Vice-Chairman of both NECCA (New England Council of Callers Association) and Co-op (New England Square and Round Dance Cooperation Committee). He teaches classes and is club caller for two local clubs, one of which he has been club caller/class teacher for 22 years. Bob Osgood



Bob was one of the visionaries and charter members of CALLERLAB. He served as Executive Secretary during the formative years of CALLERLAB without any financial remuneration and used the good offices of SIO as his base, donating his time and financial resources. Bob was honored in 1978 with the CALLERLAB Milestone Award and is currently a Gold Card Holder. Bob has served on the Board of Governors since the start of CALLERLAB and is currently the Chairman of the Board. Bob was also one of those involved in the formation of LEGACY, the coordinating and communication phase of the square dance activity. He was awarded the first Heritage Award from LEGACY in 1985. Bob has been editor of SQUARE DANCING (Sets in Order) Magazine. The publication of this magazine stopped with its 444th issue in December 1985 as the first of a number of steps in cutting back on his work and leading to a semi-retirement. Next year will mark his 50th year of calling and teaching square dancing. Bob firmly believes that CALLERLAB is the best way to achieve our ideals as caller/leaders.

Tony Oxendine



Tony started calling in 1974. By 1978 he decided to pursue a full time calling career. Now he travels well over 100,000 miles annually calling over 300 dances a year all over the country. He has also called in such exotic places as Saudi Arabia, Japan, Sweden and England. Tony calls all programs through A-2 and has recently started teaching and calling C-1. He feels that because of his travels he can maintain a finger on the pulse of the Square Dance Activity. Tony is co-owner and co-producer of Royal Records. A member of CALLERLAB since 1983, he is very active with several committees and is currently chairman of the Plus Quarterly Selection Committee. Mona Cannell, Chairman of the CALLERLAB Contra and Traditional Dance Committee, announced that "PATRIOT'S JIG" has been chosen as the Contra of the Quarter for the 4th quarter 1987. "PATRIOT'S JIG" was authored by Ted Sannella. Note that this dance is the original version which was later simplified by changing the formation from couple facing couple to improper duple. This dance should be attempted only after dancers have some experience in dancing contras.

PATRIOT'S JIG
By Ted Sannella

Formation: Couple facing couple in long lines*
Music: Back to Donegal, Windsor 4183; Sherbrooke, Lloyd Shaw 302

- (A1) 1- 4 Allemande Left your corner,
- 5-16 With your partner Swing
- (A2) 17-24 In your lines go Forward and Back,
- 25-32 With opposite couple Circle Four 3/4,
- (all facing up & down the set) now Pass Thru,
- (B1) 33-40 Swing the next (the one you meet)
- 41-48 Put her on the right, go Right and Left Thru
- (B2) 49-56 Same two Ladies Chain across,
- 57-64 Same two couples Right and Left Thru

* Probably the easiest way to set up this formation is from a static square. Have the heads lead right and Circle to a Line, then join hands in long lines up and down the hall. Make sure dancers adjust so each couple is directly facing another couple.

Mona Cannell, Chairman of the CALLERLAB Contra and Traditional Dance Committee, has announced that "GRAND SASHAY" has been chosen as the Traditional Dance of the Quarter for the 4th quarter of 1987.

GRAND SASHAY

References: Five Years of Sets in Order, Bob Osgood, 1954

Dance Call:

Allemande Left the corner,
Let's do the GRAND SASHAY,
Dosado your partner,
Now right hand pull by,
See saw round the next one,
Now left hand pull by,
It's a Dosado the next one,
Again right hand pull by,
See saw round the next one,
Left hand pull by,
Swing the next one,
That's your partner, Promenade home.

Dance Description:

The description of how to dance GRAND SASHAY is sufficiently clear from the dance call; however, dancers should be cautioned to pull by smoothly without jerking or pulling someone's arm out of the socket. When called as shown above, the figure times out to 64 counts and works well as an opener, break or closer in a standard singing call. A number of years ago, the term sashay was the Texas equivalent for the dosado and the GRAND SASHAY became a combination or progressive right and left shoulder dosados or sashays.

Convention Exhibitor Policy Update

Our past policy relating to exhibitors was reviewed because it was generally felt that it needed to be modified. The following policy will apply without exception:

1. All CALLERLAB callers and those people whose product or service is primarily or use by callers are eligible to exhibit with CALLERLAB.
2. All exhibitors must stay in the headquarters hotel -- no exceptions to this policy.
3. If an exhibitor is not registered to attend the convention, there will be an additional exhibitor fee of not less than \$50.00.

Mainstream Quarterly Selection Keep/Drop Ballot

A "Mainstream Keep/Drop" Ballot has been included along with this issue of DIRECTION. Our current policies state that each movement selected as a quarterly selection must be reviewed six months after that selection to decide whether or not it should remain as a quarterly selection.

The ballot is self-explanatory and must be returned no later than October 1, 1987. Your prompt attention to the completion and return of this ballot will be very much appreciated. The results of this ballot will be announced in a future issue of DIRECTION.
