The following are the resolutions presented and voted upon at the Wednesday morning closing session. In the interest of conserving space in this issue of DI-RECTION, please note that all resolutions that were passed are followed with "MSC".

A ballot (separate enclosure) has been enclosed for those who were unable to attend. Specific directions for voting are included. Please read carefully!

Accreditation Committee - Ernie Kinney, Acting Chairman

WHEREAS the current requirement for CALLERLAB membership is to become accredited within two (2) years of becoming a member or subscriber of CALLERLAB,

AND WHEREAS the current requirement for continuous membership in CALLERLAB requires re-accreditation every six (6) years for members or subscribers.

AND WHEREAS the Accreditation Committee believes Accreditation should be more meaningful and voluntary, 3.5

BE IT RESOLVED that mandatory accreditation for members and subscribers be rescinded. Motion was seconded and DEFEATED. 7 367

Accreditation procedures and policies will remain the same.

Proposal to Change the Life of a Quarterly Selection - Jack Lasry, QS Coordinator

BE IT RESOLVED that the life of any quarterly selection be reduced from the present three (3) years to two (2) years, At the end of two years, the guarterly selection would be dropped from the designated QS program and be voted upon for addition to the appropriate list as a permanent basic. In the event the call is not accepted as a basic on the appropriate list, it would be "dead".

This motion was seconded and following a brief discussion, the motion was tabled to next year's convention.

Mainstream Quarterly Selection Committee - Kenny Farris, Chairman

The Mainstream Quarterly Selection Committee would like to restate the following concerning proper usage of quarterly selections.

- 1. QS calls are not a mandatory part of any program. Dancers are not to be held accountable for selections past or present.
- QS calls should be verbally mentioned and/or physically workshopped prior to being called the first time at an open dance. QS calls to be used at the caller's discretion.
- 3. Conventions and festivals shall be encouraged to delete quarterly selections from all designated halls. For example, the Mainstream Hall should read MS, not MS + QS or MSQS.

THANK YOU FROM CHAIRMAN DARRYL MCMILLAN

Chairman of the Board, Darryl McMillan, thanked all those in attendance for their active participation, etc. Overall this was an excellent convention in which an attitude of enthusiasm and cooperation prevailed. The video tapes spearheaded by Member Jack Berg, were very well-received and all involved are to be commended for their efforts. A twelve (12) hour continuous display provided opportunity for all to see what the potential is for use of these tapes as recruiting vehicles. The rest is up to us!

BALLOT VOTING

The ballot is being sent out to all Members and Subscribers who did not attend the 1989 Nashville Convention. The required change in our By-Laws was officially ratified in Nashville. This policy allows for all convention items to be voted upon by the membership of CALLERLAB. If 2/3 of those not attending the convention vote disagreement on any item, that item <u>must</u> be scheduled for discussion at the next scheduled convention.

TETON MOUNTAIN STOMP (Mixer)

Music: Windsor 4615, Shaw E-36

Formation: Circle of couples, partners in closed position, man facing line of dance.

(CCW) (For CD use, have all face partner and join both hands.)

Footwork: Opposite throughout, man begins with left foot, woman with right.

** All changes of direction are done by each dancer doing an individual U Turn Back WITHOUT dropping hands. After second change of direction, partners drop hands and walk forward in the direction each is facing (man in LOD, woman in RLOD; or man, CCW and woman CW) PASSING ONE person to swing the next dancer (8 counts) to end with man facing LOD to begin dance again.

Note: The original dance as written for measures 13-16 has two turning two steps and four pivot steps in closed position. There are many variations of this dance in The Contra and Traditional Dance Committee recommends that whichever variation is popular in your area be used with the proviso that the dance be kept as simple as possible.
