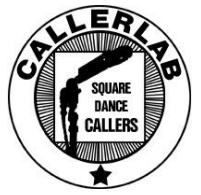

# RENEWAL INFORMATION

## TO THE APPLICANT:

To insure the reasonable timeliness of each certification authorized by CALLERLAB, no certificate shall be deemed valid for a period of more than six (6) years.

Prior to the expiration of a caller's current certification, he or she may elect to apply for such certification by obtaining the signature of one Certifier to certify that the applicant has been actively\*\* calling, without significant interruption, since the issue date shown on the applicants current certificate.

### Renewal Procedure:

Certified callers who desire to have their current certification renewed for an additional six years may submit an application for renewal no earlier than six months prior to the expiration date shown on their current certificate and no later than six months thereafter.

To apply for renewal, an applicant should:

1. Complete the application on the reverse side of this form and obtain a certifier's signature.
2. Sign the declaration at the bottom of the application and indicate the date.
3. Mail the completed application together with a renewal fee of **\$25.00(U.S. Funds)** to:

4. No partial or incomplete application will be considered.
5. Upon the granting of a certification renewal, a new certificate will be mailed to the applicant, showing the new effective dates of that certification.

## TO THE CERTIFIER:

You may serve as a certifier for a renewal applicant provided that:

1. You are currently a CALLERLAB Member or Associate Member in good standing.
2. You agree to serve as a certifier only when you have personal and first-hand knowledge that the applicant is currently certified by CALLERLAB and that the applicant has been actively\*\* calling for a period of not less than six (6) years immediately preceding the date indicated after your signature.
3. You do not serve as a renewal certifier for any applicant who has served or who may subsequently serve as a certifier on your own application for certification or renewal.
